This agreement shall remain in effect for the period of ownership by the named Adopting New Owner only and is NOT transferable.

TRANSACTION DETAILS, INCLUDING BREEDING RIGHTS & HEALTH GUARANTEES:

- A nonrefundable adoption down payment of **\$250** has been collected from the Adopting New Owner on ____/____/____ (date).
- The remaining adoption payment of **\$2,250** will be collected from the Adopting New Owner on the Saturday after the puppy turns eight weeks old on **08/07/21** (date). Payments must be made in cash, or if by bank deposit, the monies must clear the bank prior to taking your puppy home. This can take up to 30 days, so plan appropriately. Puppies cannot leave Mountainview Mini Doodles until monies are assumed.
- The Adoption Agreement EXCLUDES the right to breed or use of the puppy for stud services. The Adopting New Owner agrees to pay **\$1500** to Mountainview Mini Doodles for the right to breed or use the puppy for stud service at the time of final payment. An additional contract and Embark Health testing (approximately \$150) must be completed and approved by Mountainview Mini Doodles prior to breeding rights.
- Proof of spay/neuter MUST be provided to Mountainview Mini Doodles within 6-13 months.
- The puppy is guaranteed to be in good health at the time of departure to its new home. The New Owner has a 72-hour window to have the puppy health checked by their licensed veterinarian. If the vet finds anything seriously wrong with the puppy, it will be exchanged for a similar puppy at once or as soon as one is available. Prior to this occurring, the vet must provide a letter from their office stating the problem that makes the puppy unworthy of being adopted and the puppy must be returned within the 72-hour guarantee window. If the New Owner is not local, arrangements can be made if Mountainview Mini Doodles is notified with the letter within 72 hours. Once the puppy has cleared the exam, it will be understood that Mountainview Mini Doodles has provided a healthy puppy and that the care and health of the puppy is that of the New Owner. All vet bills, medicines, and/or treatments are the expenses of the New Owner from the time the puppy leaves Mountainview Mini Doodles, including the New Owner's vet exam.
- The following MUST occur for the replacement or refund of the adoption price of the puppy:
Claims must be accompanied by the veterinarian's statement with a full explanation of the problem, lab tests acquired, medications given, etc. and be received by Mountainview Mini Doodles within 14 days of the vet visit. The dog must be returned to Mountainview Mini Doodles at the New Owner's expense for re-evaluation by a veterinarian of Mountainview Mini Doodles choice. If a difference of opinion occurs between the vets, then the advice and/or diagnosis of Mountainview Mini Doodles' veterinarian will override the diagnosis of the New Owner's veterinarian. If it is necessary to put the puppy down at the time, it will be humanely euthanized at Mountainview Mini Doodles' expense.
If the replacement option is chosen, then a comparable (breed/sex/color) replacement puppy will be provided when one is available.
- Mountainview Mini Doodles does not guarantee against environmental or stress-related illnesses beyond our control; including but not limited to pneumonia, hypoglycemia, kennel cough, or allergies. Defects caused by human error, vaccine efficacy, Addison's disease (since there are no screening tests for this) or improper diet or exercise are not guaranteed. The contraction of viruses, worms, coccidian, giardia, etc. are not guaranteed.
- Please note: Do not sign this Adoption Agreement if the terms are not satisfactory. Terminate or put this agreement on hold until satisfaction is met. Upon signing this document, you agree to all terms.

ADOPTING NEW OWNER

- I agree that I will care for the puppy in a safe and humane manner, and as a family pet and companion. The dog will have appropriate food, water, shelter, and medical care for the duration of his/her life.
- I understand all the health guarantees.
- I understand the processes to complete, handling of the costs, and my options if the puppy does have a genetic, hereditary defect which makes it unsuitable to be a companion.
- I understand that Mountainview Mini Doodles makes no guarantee or warranty regarding the temperament of the dog. Mountainview Mini Doodles shall not be held liable for the behavior of the dog or any damages it may cause.

- I enter into this agreement on my own free will and understand that it is a binding contract enforceable by civil law.
